1. I hereby agree to breed \_\_\_\_\_ Reg. No. \_\_\_\_\_ to COPOTE PEAK standing at The Duncan Ranch for the 2008 breeding season and will pay a total stud fee of \$750.00 (Seven Hundred and fifty Dollars) this includes a non-refundable Booking Fee of \$150.00 (One Hundred and Fifty Dollars) that must be returned with this signed and dated contract. The contract and booking fee must be returned prior to the arrival of the mare or this contract becomes null and void. This contract must be returned completed and intact for approval signature before fore mentioned mare will be bred. All other expenses including chute fee's, board, vet expenses, hoof care, etc. may be billed on a monthly basis. ALL BILLS MUST BE PAID IN FULL PRIOR TO DEPARTURE OF MARE.

2. Live foal guaranteed with return privilege the following season only if the mare fails to produce a live foal after being tested in-foal by a licensed veterinarian. It is understood that should the foal not stand and nurse, the mare will be entitled to return privilege the following year only. This guarantee applies only if the stallion owner is notified within one week of the death of the foal. This notice must be accompanied by a statement from a licensed veterinarian. If the mare is to be returned, and the owner of the mare fails to deliver her for rebreeding during the following year, then any and all fees shall not be refunded and this contract is thereby cancelled.

3. Diligent efforts will be made to impregnate my mare, however, if for any reason she does not become pregnant, I will not hold the stallion owner or his representatives liable. The breeding season will begin Mar. 1<sup>st</sup> and close Aug 15<sup>th</sup>. I agree to have pregnancy examinations done by a licensed veterinarian within 45 days of last cover or insemination. I agree to notify The Duncan Ranch of the results of all pregnancy tests in writing within one week of the test. In the event of failed pregnancy tests prior too the end of breeding season, I agree to submit the mare for another cover. This will entitle the mare owner to one return breeding for the following year only in the event that she does not produce a live foal.

4. Please be aware that there will be no right-of return privileges granted for mares that are either not pregnancy tested, or that fail pregnancy tests prior too the end of breeding season and are not resubmitted for live cover.

5. It is further understood that should the above named stallion die or become unfit for stallion service, this contract shall become null and void and the breeding fee will be refunded.

6. The Breeder's Certificate will be issued upon notification of the birth of the foal, unless the breeding fee, mare care, or any other associated fees have not been paid in full.

7. All mares must have a current, negative Coggins test and be current on all vaccinations and de-worming. If the owner cannot show proof of vaccination/de-worming status, the mare will be vaccinated upon arrival at The Duncan Ranch.

8. A copy of the mare's registration papers/certificate must be furnished with the completed stallion contract.

9. I understand and agree that neither The Duncan Ranch nor their representatives will be held responsible for accidents, sickness, or death to my mare and/or foal. Furthermore, I agree that the above named parties shall not be held liable for any negligence or errors and that the above named parties may exercise their judgment in supervising and caring for the animals at the facility. I agree that the above named assume no liability whatsoever for mares/horses and owners.

10. I agree that the Duncan Ranch's veterinarian may examine my mare/horse for normal breeding conditions and to perform such other services deemed necessary for the proper care of the animal at the owner's expense.
